# HILLSBOROUGH TOWNSHIP BOARD OF EDUCATION March 24, 2008

The Board of Education of Hillsborough Township in the county of Somerset, convened in public session on Monday, March 24, 2008 at 6:30 p.m. in the cafeteria of the Auten Road Intermediate School in the School District.

#### Executive Session

A motion was made by Mr. Paget and seconded by Mr. Blandino that the board adopt a resolution to go into executive session.

WHEREAS, the Open Public Meetings Act, Chapter 231 of the Laws of 1975 provides that a public body may exclude the public from that portion of a meeting of which the public body discusses certain matters for which confidentiality is required as permitted in Section 7B of the act.

RESOLVED, by the Board of Education of the Township of Hillsborough in the County of Somerset and State of New Jersey as follows:

Upon call of the roll, the motion carried with a unanimous vote recorded.

The board reconvened in public session at 7:30 p.m.

A motion was made by Mr. Kanaby and seconded by Mr. Rosenberg that the board of education approve the minutes of the work session held on February 11, 2008

Upon call of the question, the motion carried unanimously.

A motion was made by Mr. Kanaby and seconded by Mr. Schneider that the board of education approve the minutes of the regular meeting held on February 25, 2008.

Upon call of the question, the motion carried unanimously.

A motion was made by Mr. Paget and seconded by Mr. Blandino that the board of education approve the minutes of the executive session held on February 25, 2008.

Upon call of the question, the motion carried unanimously.

# Correspondence

President Hudes distributed a letter from Peggy Cioce, district fine and performing arts supervisor, regarding the Star Search program.

# Recognition

Dr. Forsthoffer introduced Mr. Robert Fenster, Hillsborough High School debate team advisor, who spoke about the debate team which is comprised of the Model UN team and the Model Congress team. He noted their many awards. He then introduced the members of the team and congratulated them on their outstanding accomplishments. Mr. Fenster stated that for the last 7 years, Hillsborough has taken either first or second place at competitions.

Mr. Fenster also spoke of the Mock Trial team, for which he is also the advisor. He explained that the team gets a fictional case where the students must prepare as attorneys and as witnesses. He noted that the team won the county championship after an undefeated season. Mr. Fenster stated that both the debate team and mock trial team always represents Hillsborough with class and dignity. He then introduced the members of the mock trial team.

President Hudes congratulated the students and their families.

# Public Hearing on the 2008-2009 Budget

Dr. Forsthoffer presented a slide presentation to introduce the 2008/09 budget. Some key points of this budget are:

- \* Input from board, staff and public
- \* Budget below state mandate 4% cap
- \* State aid increase of \$4.2 million or 20%
- \* Student centered, decisions made based on student needs
- \* All existing programs maintained
- \* Add in-house Behaviorist
- \* Increase in Capital Improvements

- \* Tax rate increase of only 1 cent for every \$100 of assessed value
- \* State aid will not increase for 2009-2010
- \* Minimal staffing increase
- \* 5 year curriculum plan is on target
- \* Budget \$106,282,590
- \* 52% of spending is for instruction

Dr. Forsthoffer thanked the audience for their time and opened the floor for questions and comments on his proposed budget.

There were no public comments or questions related to the proposed budget.

Mr. Blandino asked what happens to budget monies that are not spent in the budget year.

Mr. Mahmoud explained that typically those funds end up being surplus and can help balance the following years budget.

Mr. Blandino stated that he thinks the people of Hillsborough deserve a budget with no increase. He also stated that he thinks the board should cut \$780,000 from personnel and from capital projects to bring the budget to a zero increase.

Mr. Paget spoke in length about the budget process and his position that the budget as presented is a frugal budget. He went on to say that this budget provides the smallest tax increase in years. The increase in taxes is due to spending money on facility improvements and that the money is being spent wisely. We put 63% of our money into the classroom where nearby Montgomery puts only 56% of their money into the classroom.

Mr. Gillette stated that the finance committee has looked for every possible cost savings and thinks that there could have been a zero increase budget had it not been for the unexpected replacement of the Sunnymead roof. He also stated that there is nothing in this budget that we can live without.

Mr. Rosenberg commented that we are professionalizing the Human Resources department and are attempting to make Hillsborough a district where people want to come to work. He also states that he has never seen better public relations and communications with the public and the press than there is now with the Public Information Officer and thinks it is a position that should go to full time as proposed.

President Hudes thanked the finance committee and the administration for their work in developing the budget and noted that Hillsborough compares very favorably with other districts.

President Hudes went on to suggest that the board include the Athletic Strategic Plan that was adopted several years ago. This plan identifies the expansion of some of the programs that the district offers to the students. The programs that should be expanded this year are boys and girls volleyball, adding a coach to the winter track team and add bowling.

This board has historically increased staffing consistent with enrollment increases. Now that enrollment has leveled off we should not be asking the public to increase the staffing levels.

Mr. Kanaby stated that since the high school enrollment is actually increasing by 94 students he does not recommend cutting a physical education teacher at the high school.

Mr. Rosenberg stated that bowling has come up before. In the past, it was included as part of a second question that was turned down by the public. He is concerned that we would add \$10,000 for bowling at the expense of adding a needed teacher in world language.

Mr. Donnadio asked how much would the proposed cuts in positions save taxpayers.

Dr. Forsthoffer stated that each \$20,800 would lower the increase by one dollar.

Dr. Forsthoffer also justified the new positions at the direction of Mr. Donnadio.

Mr. Donnadio asked Dr. Forsthoffer if we were to cut these positions, would we then need to add them in future years.

Dr. Forsthoffer responded that we would need to add these positions at some point in the near future if we cut them this year.

Mr. Blandino raised a question about bonding some of the facilities work that is in the budget.

Mr. Paget responded by stating that the district tried that recently and the public voted it down. This was done at a time when there could have been matching funds from the state.

Mr. Gillette stated that the finance committee discussed the option of bonding and prefers to avoid taking on additional debt. He also stated that the board can not risk having the public vote down a project that is necessary.

Mr. Lin stated that he believes if the town votes down a project on a referendum, the project can not be done within the next year's budget.

Mr. Hudes commented that the Athletic Strategic Plan was created by a committee and approved by the board and we should follow through on the plan.

#### New Business

Shawn Fleming wanted to make the board and the public aware of an accident he had with one of the school buses in 2003. He stated that there were no injuries and the only damage to a vehicle was the damage to his car. He stated that the accident was not reported at that time and he feels that he should report it so the parents of the students on the bus are aware of it. He apologizes to the families that they were not informed at the time of the accident.

# Local Tax Levy for Budget

Resolved, that there should be raised for General Funds \$69,907,530 for the ensuing school year (2008-09). The school district has proposed programs and services in addition to the core curriculum content standards adopted by the State Board of Education. Information on this budget and the programs and services it provides is available from your local school district.

A motion was made by Mr. Schneider and seconded by Mr. Rosenberg to amend the budget by reducing \$47,000 in proposed salaries from appropriations.

Upon call of the roll, the motion to amend failed with three members voting in favor and Messrs. Donnadio, Gillette, Kanaby, Lin, Paget, and Rosenberg voting against.

A motion was made by Mr. Blandino and seconded by Mr. Rosenberg to amend to the budget by cutting the high school physical education teaching position.

Upon call of the roll, the motion to amend failed with three members voting in favor and Messrs. Donnadio, Gillette, Kanaby, Lin, Paget, and Rosenberg voting against.

A motion was made by Mr. Hudes and seconded by Mr. Lin to amend the budget by removing all proposed positions totaling \$209,000 and to fund the athletic strategic plan in the amount of \$26,296.

Upon call of the roll, the motion to amend failed with two members voting in favor and Messrs. Donnadio, Gillette, Kanaby, Lin, Paget, Rosenberg and Schneider voting against.

A motion was made by Mr. Kanaby and seconded by Mr. Rosenberg to amend the budget by increasing appropriations in the amount of \$16,432 to add the volley ball and winter track portion of the athletic strategic plan.

The motion to amend the budget failed with one member voting in favor and Messrs. Blandino, Donnadio, Gillette, Hudes, Lin, Paget, Rosenberg, and Schneider voting against.

A motion was made by Mr. Blandino and seconded by Mr. Hudes to amend the budget by cutting the high school attendance position valued at \$18,500.

The motion to amend the budget failed with four members voting in favor and Messrs. Gillette, Kanaby, Lin, Paget, and Rosenberg voting against.

A motion was made by Mr. Paget and seconded by Mr. Lin to amend the budget by eliminating the high school clerk position valued at \$14,123 and adding the middle school volleyball program and winter track valued at \$16,432.

Mr. Paget removed the above motion. All were in favor.

A motion was made by President Hudes and seconded by Mr. Kanaby to amend the budget by including the athletic strategic plan valued at \$26,296 funded through breakage.

Upon call of the roll, the motion failed with four members voting in favor and Messrs. Blandino, Donnadio, Gillette, Lin, and Rosenberg voting against.

Upon call of the roll of the original motion to approve the budget as submitted, the motion carried with eight members voting in favor and Mr. Blandino voting against.

# Bid Threshold/Qualified Purchasing Agent Appointment

Approve the following resolution for increasing the bid threshold and appointing a Qualified Purchasing Agent, pursuant to N.J.S.A. 18A:18A-3a and N.J.A.C. 5:34-5 et seq.:

WHEREAS, the recent changes to the Public School Contracts Law gave boards of education the ability to increase their bid threshold up to \$29,000; and

WHEREAS, N.J.S.A. 18A:18A-3a, permits an increase in the bid threshold if a Qualified Purchasing Agent is appointed as well as granted the authorization to negotiate and award such contracts below the bid threshold; and

WHEREAS, Aiman Mahmoud possesses the designation of Qualified Purchasing Agent as issued by the Director of the Division of Local Government Services in accordance with N.J.A.C. 5:34-5 et seq.; and

WHEREAS, the Hillsborough Township Board of Education desires to increase the bid threshold as provided in N.J.S.A. 18A:18A-3a, now, therefore be it
