New Business

Leslie Jones, Hillsborough resident and parent, discussed the summer reading program, noting that while books chosen were excellent choices, they were somewhat disturbing subjects. She asked what criteria was used in selecting the books. She also questioned why summer reading books were not usually adventures or cheerful subjects.

Dr. Antunes described the process of the book selection and explained that there is usually a choice of books to read.

Mr. Blandino, facilities committee chairperson, reported that the committee met on July 12 and discussed the following items:

- Turf field analysis savings/cost avoidance is approximately \$14,000 per year
- Custodial/Maintenance in-house vs. contracted services

Mr. Blandino explained that the district consulted with an architect and engineer regarding the Auten Road Intermediate School air conditioning. They determined that the use of window units would be problematic (leaks, low energy, electrical capacity) and consequently rejected the idea. The engineers feel that the proper way to handle the providing of air conditioning is to install a chiller based system with piping to each 2nd floor classroom and a chiller coil in each unit ventilator at a cost in the \$500,000 range. An alternative to this would be a condenser unit on the roof for each classroom which would run slightly below this estimate. The district will need to look at the cost for a full evaluation if it wishes to pursue this further. The next committee meeting is scheduled for August 16.

Time was allowed for questions and comments on the committee reports.

Superintendent's Report

Dr. Antunes informed the board and public that Camp Heart is running smoothly this summer.

Dr. Antunes gave a presentation on the annual mandate "Framework for Accountability." The presentation highlights district test scores and adequate yearly progress. The presentation will be available on the district website.
